#### Terms of Reference:

- i. To formulate policies and procedures for planning, designing and implementation of the construction and infrastructure development programme of IBSD.
- ii. To examine and approve plans, programmes of major construction and infrastructure development work.
- iii. To select an Architectural Consultancy firm for the IBSD construction and infrastructure projects.
- iv. To decide Project Management Consultancy arrangement for management and execution of projects.
- v. To accord administrative approval of major construction projects.
- vi. To approve award of major contracts for the construction projects.
- vii. To approve revisions in cost estimates/revised cost of major construction work.
- viii. To periodically monitor/review the progress of major activities related to construction programmes.
- ix. Committee will be delegated with powers to decide on the implementation of the construction and infrastructure programmes and in particular in respect of the terms of reference nos v, vi and vii above.
- x. Non-official members will be paid TA/DA and sitting fee as per rules while attending the meeting.
- xi. The tenure of the committee will be for a period of 3 (three) years.
